Example 1: Harvest Permit Payment (Stumpage) Invoice

Applicable to: All Timber Harvesters in Forest Reserves and Free Areas

Exemption: None

Purpose and content of document: A Harvest Permit Payment Invoice is the evidence of payment for the right to harvest in allocated forest compartments. It is also an important document for applying for a harvesting permit. Without a Harvest Permit Payment Invoice the harvesting permit cannot be issued and Concession would not be granted. The contents of the Harvest Permit Payment Invoice include name of owner of forest or forest land, location of forest, species, area of forest, forest type, period of time managing the forest etc.

Holder of document: Timber Harvesters

Document issued by: State Department of Forestry

Signature/Seal required by: Designated Forestry Department official

- □ Is the invoice still valid?
- □ Is the name of the owner the same as that on the Harvesting Permit or Forest Compartment Allocation?
- Is the name the same as shown on the Vehicle Registration Invoice (Example 12), i.e. the harvesting area from which the timbers are transported?
- Is the name the same as that shown in the Business Registration Certificate (Example 14), i.e. Certificate of Incorporation?

Example 2: Sample of Block Permit

Applicable to: Timber harvesters after payment of Harvesting Permit Fees and Forest Compartment Allocation Fees.

Exemption: None

Purpose and content of document: A Block Permit (A Block Permit is essentially the same as a Harvesting Permit, but different terminologies are used in different states) is the evidence of right of use of Forest Reserves for timber harvesting purposes. The contents of a Block Permit include name of owner of forest allocated, permit number, location of forest, species, area of forest, forest type, period of time, etc.

Holder of document: Timber Harvesters

Document issued by: State Departments of Forestry

Signature/Seal required by: Provincial Forest Officer

- □ Is the Permit still valid?
- □ Is the name of the owner the same as that on the invoice for payment of permit?
- Is the name the same as shown on the Vehicle Registration Invoice (Example 12), i.e. the harvesting area from which the timbers are transported?
- □ Is the name the same as that shown in the Business Registration Certificate (i.e. Certificate of Incorporation)- Example 14?
- □ Is harvesting permitted within the stated forest area? (The scope of permission is indicated in the Block Permit)

Example 3: Sample of Timber Harvesting permit (See explanation above)

Applicable to: All Timber Harvesters in Forest Reserves and Free Areas

Exemption: None

Purpose and content of document: The harvesting permit is required prior to harvesting and provides evidence of harvesting according to prescribed guidelines. Permits are issued by the States' Forestry Departments. While harvesting timber, permit holders must follow the requirements on area, species, and measures stipulated in the Harvest Permit.

Contents of the harvesting permit include permit code, harvesting location, species, harvesting locality area and quantity, time period of

harvesting and Name of authorized industry, etc.

Harvesting permits is valid for one year of harvesting. However, the permit can be renewed yearly.

Signature/seal required by: Director of Forestry

Example 4: Certificate of Occupancy

Applicable to: All private land purchased for whatever purposes in Free Areas. The land use can be forest entities and plantation.

Exemption: Harvesters do not require a Certificate of Occupancy for Government Forest Reserves or Protected Forests

Purpose and content of document: A Certificate of Occupancy is the evidence of right of use of lands for any purpose (including Forests) usually for 99 years. The contents of the Certificate of Occupancy include: Name of owner of Land or Forest land, Location of Land or Forest, Area/ Size of Land or Forest, Period of time, etc.


Holder of document: Private Landowners, Forest Owners, Timber Harvesters

Document issued by: The Federal Ministry of Power, Works and Housing, State Governments

Signature/Seal required by: The Honorable Minister of Power, Works and Housing, Governor of the State

- □ Is the certificate still valid?
- □ Is the name of the owner the same as that on the harvesting permit?
- Is the location on the certificate the same as shown on the Timber Harvesting Permit (Example 3)? For any tree harvested, either in private or public land must be approved by the Forestry Department.
- □ Is the name the same as that shown in the business registration certificate?

Example 5: Forest Compartment Allocation Fee Invoice

Applicable to: All Timber Harvesters in Forest Reserves and Free Areas

Exemption: None

Purpose and content of document: A Forest Compartment Allocation Fee Invoice is the evidence of payment for the right to harvest in allocated forest compartments. It is also an important document for applying for a

harvesting permit. Without a Harvest Permit Payment Invoice the harvesting permit cannot be issued and Concession would not be granted. The two documents are complementary and essential.

Signature/Seal required by: Director of Forestry

Example 6: Sample of Permit to take Protected species

Applicable to: All Timber Harvesters in Forest Reserves and Free Areas

Exemption: Non-Protected species or Non-CITES Listed species

Purpose and content of document: The permit is required prior to harvesting and provides evidence that protected species would only be harvested according to prescribed guidelines. Protected species can be harvested upon approval granted by the State's Forestry Department. Permits are issued by the Federal Ministry of Environment and the States' Ministry of Natural Resources. While harvesting timber, permit holders must follow the requirements on area, species, and measures stipulated in the Harvest Permit.

Contents of the harvesting permit include permit code, harvesting location, species, harvesting locality area and quantity, number of trees to be harvested, time period of harvesting, royalties payable and Name of authorized industry, etc.

Holder of document: Timber harvesters

Document issued by: State Ministry of Natural Resources through the Forest Management and Utilization Department

Signature/seal required by: The Honorable Minister represented by the Issuing Officer

Example 7: Log Evacuation Schedule

Applicable to: Timber Harvesters, Timber Contractors, Timber Transport Industries

Exemption: None

Purpose and content of document: This provides evidence that the right requirements are followed prior timber transport. This document helps to ensure that there is no mixing of legal with illegal timber during transportation. (It is the role of the Forestry officers to oversee extraction, but they are usually handicapped in carrying out that role due to lack of transport and logistical support). The contents of the schedule include: Block permit number, Forest compartment number, authority issuing the license, contractor name and address, species, particulars of species and specification, volume/quantity, validity period of the evacuation schedule.

Holder of document: Timber Harvesters, Timber Contractors

Document issued by: State Ministry of Natural Resources through the Forest Management and Utilization Department

Signature/seal required by: Forestry official

- □ Is it the correct date on the document?
- □ Is the holder the same as that given in the Timber Harvesting Permit?
- □ Is the volume equal to or lower than the Harvesting Permit volume?
- □ Is the species the same as described on the Harvesting Permit?
- □ Is the starting location for transport in the same region as the harvesting location?
- □ Is the end point the same as what the buyer claimed?

Example 8: Tax Clearance Certificate

Applicable to: All Business Entities (Forestry inclusive)

Purpose and content of document: According to Company Income Tax Act of Nigeria, Tax Clearance certificates are legally required as evidence of a company's tax payment and this is linked to the company's bank account. Contents of the tax clearance certificate are tax registration code, approval authority, name and address of taxpayer, business scope.

Holder of document: Forestry Operators, Timber Harvesters, Timber Contractors

Document issued by: Federal Ministry of Finance through the Federal Inland Revenue Services (FIRS)

Signature/Seal required by: Taxes are collected by the FIRS Integrated Tax Offices (ITO) located in each state.

- □ Is the name the same as that shown on the business registration certificate?
- □ Is the tax registration code the same as that shown on the invoice issued by the tax registration certificate holder?
- □ Is the certificate valid?
- □ Is the business scope the same as it is on the business registration certificate?

While harvesting timber, permit holders must follow the requirements on area, species, and measures stipulated in the Harvest Permit. Contents of the harvesting permit include permit code, harvesting location, species, harvesting locality area and quantity, number of trees to be harvested, time period of Harvesting, royalties payable and Name of authorized industry, etc.

Document issued by: CITES Management Authority under the Department of Forestry, Federal Ministry of Environment

Signature/seal required by: The Honorable Minister of Environment

Applicable to: All entities whose activities pose threats to the environment. These include Forest operators who manage forest areas and timber harvesters. Any activity that would impact an area of more than 50 hectares requires an EIA, both for plantations and natural forest.

Exemption: Projects below 50 hectares of area of impact

Purpose and content of document: Any project or developmental activity involving clearing of forest area of more than 50 hectares is required to undertake Environment Impact Assessment. (EIA Act, 1992) The EIA is expected to be conducted by the project proponent (government or private) and approved by the EIA department of the Federal Ministry of Environment. An ancillary part of EIA Report is an Environmental Management Plan which incorporates monitoring of mitigation measures for envisaged negative impacts.

Applicable to: All Timber Harvesters

Exemption: None

Purpose and content of document: Trees felled have to be transported from the forests to points of use. This document is required to ensure that illegal or unregistered vehicles do not enter the forest reserves or areas. This is to curb mixing of legal with illegal timber during transportation, however, monitoring by forestry officials is low due to lack of logistical support.

Holder of document: Transportation entities responsible for the transport of the timber, Timber Harvesters



Example 13: Letter of Support for Export

(As noted in the Nigeria Risks Assessment, there is a long list of conditions to be met before a Letter of Support of Export is issued) However, the Letter of Support for Export is issued by the Federal Department of Forestry (i.e. Agency of the Federal Government) that has no control over what happens at the field level (i.e. State Forestry Departments). Consequently, it is a general document allowing a company to export thus the clauses only includes the Maximum Allowable Dimensions and the compulsory pre-shipment inspection by the Wood Inspectorate Unit at the Ports of Export.

Applicable to: All Timber Exporters

Exemption: None

Purpose and content of document: This serves as an approval from the Federal Ministry of Environment for the export of processed and semi-processed wood products. This document contains the requirements for the product to be exported, the minimum allowable dimensions and the validity of the Support, which is 12 months.

Applicable to: All Business Entities (Forestry inclusive)

Purpose and content of document:

It is required by the Corporate Affairs Commission that all companies irrespective of their activities must be duly registered according to the guidelines stipulated in the Company and Allied Matters Act, 2004. The company must have a Memorandum and Article of Association which must clearly indicate interest in forestry related activities.

The companies must have:

- a valid Business Registration Certificate,
- a Business/ Company Profile stating all the activities within jurisdiction to which the company is permitted to operate,
- a declaration of Compliance,
- the profile and particulars of members of the board of directors,
- a valid means of Identification, and a Certificate of Incorporation (Corporate Partner).

The business registration certificate is given to legally established companies. Contents of business registration license include: name and address of the company, type of the certificate, investor, issuing date, business scope, business registration number, registration organization etc.



Example 15: Bill of Lading (B/L)

Applicable to: Business Entities who export timber to other countries

Purpose and content of document:

A Bill of Lading (B/L) is a legal document that serves to ensure that the shipper receives payment for the goods exported, and the consignee or importer receives goods ordered. In Nigeria, the bill of lading is a transport document that must be presented to the Nigerian Customs Services for customs clearance for export.

As a receipt, the bill of lading serves to certify to the shipper by the carrier (transporter) of goods or consignment that such goods are received and confirmed and as document of title (proof of ownership of goods). In other words, it means that the transporter has received and confirmed the goods and has agreed to deliver the said goods to destination of interest. Hence the bill of lading is usually issued by the carrier to the shipper and made available to the importer for clearance purposes. The importer in turn must make the bill of lading available to the transporter company at destination locality before cargo carriage.

The contents include the following; Bill of lading number, Place and Date of issuance, Booking number, Export reference, Consignor's name and address, Importer or consignee's name and address, Carrier or transporter's detail, Ocean vessel name/voyage number, Port of loading, Delivery port, Container number and seal, Container size, Total number of containers, Description of packages and goods, Quantity, Gross weight, Measurement, Signature of carrier, Dates of departure and arrival, Signature of consignee.

A major prerequisite for export of log is the issuance of a pre-shipment certificate from The Federal Ministry of Environment located at the Exit points. This is given after the pre-shipment inspection has been carried out.

The contents of the pre-shipment certificate include:

Certificate number, Date of issuance, Container number (s), Contents of the container, Source/ State, Destination, Wood species/ Details, Shipping company, Exporter's name and address, Forwarding agent's name and address and the Issuing Officer's Name and Signature.
