The EU Regulation on deforestation free products

The Regulation requires that products are produced in compliance with relevant legislation and that they are deforestation-free.

In order to address these requirements for agricultural commodities and wood products respectively, indicators of the Sustainability Framework are marked to show if they are relevant to the EU Regulation.

The Sustainability Framework can be used to ensure alignment with the requirements of the EU Regulation on deforestation free products by following the set of indicators marked as being applicable for the Regulation.

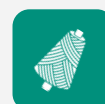

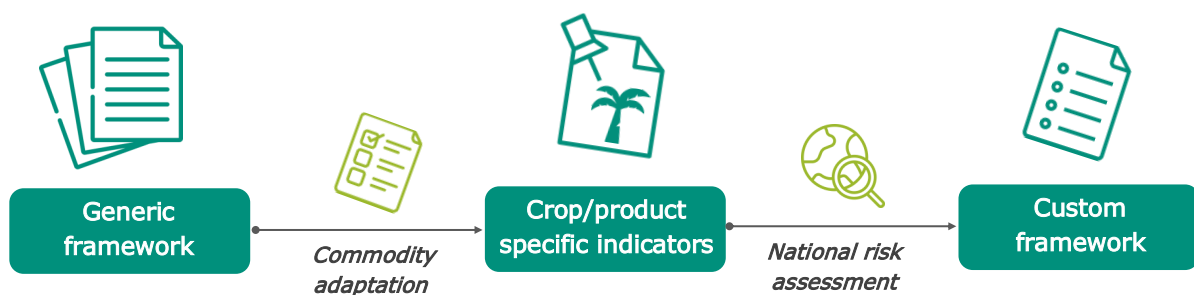
