### Introduction

Preferred by Nature is conducting an FSC® forest management and chain of custody certification audit of Eastern Ontario Forest Group located in Kemptville, Ontario, Canada. The evaluation will be conducted during the week of **October 21, 2022**.

### Scope of Evaluation

The FSC® certification audit will assess the environmental, silvicultural and socioeconomic aspects of the forest management unit(s) managed by Eastern Ontario Forest Group, using the Regional FSC FM Standard - Great Lakes St. Lawrence (2010). ## Steps and Schedule

Following is a short description of the evaluation process and a tentative agenda:

- Field visits – During the week of **October 21, 2022**, the audit team will conduct field visits of recent and active forest management operations on the certified area.
- Stakeholder and Indigenous communities/peoples' consultation – Throughout the fieldwork, the team will contact local stakeholders and indigenous communities/peoples regarding the forest management activities of certificate holder in communities surrounding the forest area. This can include private interviews and discussions as well as public meetings.
- Final evaluation briefing – Prior to departure the team will meet with the certificate holder forest managers and other parties to finalize their data collection and present preliminary findings.
- Draft report production – The audit team will produce a confidential draft report that will be circulated for comment to the certificate holder This should occur within one month after completion of the evaluation.
- Certification decision – Upon receipt of comments on the draft report from the certificate holder forest managers, and other general stakeholder and indigenous communities/peoples' comments, Preferred by Nature will reach a certification decision. Barring unforeseen obstacles, this should occur by **mid December 2022**.

## Your Comments Sought

As a part of the audit process, we invite stakeholders and indigenous communities/peoples to offer comments on the certificate holder's forest management activities in relation to conformance with the requirements of the forest management standard referenced above. **We welcome input, either public or confidential.** Your input will be valuable at any stage of the process, but we would prefer to receive your comments before the end of the on-site audit so that we can take them into consideration in reaching a certification decision. Your options for communicating your comments are as follows:

1. Meet with a Preferred by Nature audit team member before or during the audit.
